

GENERAL MISDEMEANOR GUILTY PLEA FORM

9. I understand I have the right to enter my plea before, and be sentenced by, a judge. I give up this right and agree to enter my plea before, and be sentenced by, a commissioner or temporary judge. AS ASSIGNED (Enter name of commissioner or pro tem judge).

My plea of GUILTY is made with a full understanding of all the matters set forth in the Complaint and in this form, which I declare under penalty of perjury that I have read, understood, and that I have personally initialed each item herein. I further declare that everything on this form is true and correct and understand that the signing and filing of this form is conclusive evidence that I have pleaded guilty to the charges set forth.

12. Factual basis: On or about 5/23/08, in Orange County, I did unlawfully solicit and agree to engage in an act of prostitution with the specific intent to do so, and placed a \$100 bill on the dresser in a motel room in exchange for sex.

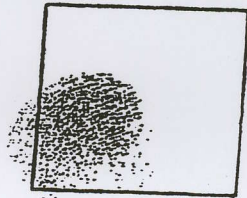
